**(Update on Previously Disclosed Matter)**  
**Announcement regarding the commencement of the Tender Offer for**  
**the Shares of “AUSTRIACARD HOLDINGS AG”, a listed Austrian company**

Dai Nippon Printing Co., Ltd. (“DNP”) hereby announces that, further to its announcement dated May 13, 2026 titled “Announcement regarding the Tender Offer for the shares of AUSTRIACARD HOLDINGS AG, a listed Austrian company” the offer document relating to the public tender offer to acquire all ordinary shares of AUSTRIACARD HOLDINGS AG (registered office: Vienna, Austria; listed on the Vienna Stock Exchange and the Euronext Athens Exchange; hereinafter “AUSTRIACARD”), which operates smart payment card, citizen identity solutions and variable security printing businesses across Europe, Africa and North America (the “Tender Offer”) has been published on June 12, 2026 (Vienna time).

The offer price under the Tender Offer amounts to EUR 10.0 per ordinary share (cum dividend). The initial acceptance period for the Tender Offer is ten (10) weeks, from June 12, 2026 to August 21, 2026 (Vienna time).

DNP currently expects to complete the acquisition of shares tendered during the initial acceptance period (i.e. settlement of the Tender Offer) in the second quarter ending September 2026 of the fiscal year of DNP ending March 2027 so that AUSTRIACARD will become its consolidated subsidiary. The settlement of the Tender Offer remains subject to obtaining certain regulatory approvals under applicable foreign direct investment regulations and competition laws, and the timing may change depending on when such approvals are obtained.
